- Represents (i) 11,080 shares or units of restricted stock, of which 4,469 are vested at the date hereof, (ii) 3,458 shares of Common Stock underlying PSUs, all of which are vested, and (iii) 1,344 shares of Common Stock purchased under the Employee Stock Purchase Plan.
