On February 17, 2015, Nasdaq's Board of Directors approved the settlement of the PSU grant. The shares underlying the PSUs vested on December 31, 2014.
- Represents the surrender of shares to pay withholding taxes in connection with the settlement of PSUs, as described above.
- Represents (i) 69,938 vested shares underlying performance share units and (ii) 638 shares purchased pursuant to the Employee Stock Purchase Plan.
